

## 1-22-15 ELDERS COMMITTEE MEETING MINUTES (DRAFT)

MINUTES-Motion to approve November's minutes of the Elder Committee meeting was made by Katie, seconded by Kay, all approved.

LPFM TASK FORCE UPDATE- Quarterly report on Community Involvement was presented to the BoD at the January 5, 2015 meeting. The task force has gathered over 150 questionnaires and survey responses from Veneta residents, the stack of mostly very supportive feedback was presented to the BoD and passed around for Elder committee review. Next step is to be added as a line item.

Archeology is fine with both possible site locations for the antennae tower at the hub. However, Terry Ney, Veneta Fire Chief has offered the use of the tower on the fire station to co-locate our antennae and also to co-house our equipment in their secure building. This is a better location and reduces our costs substantially while eliminating the need for a special use permit. Veneta is not in the tsunami zone and is planning to be command central given worse case scenarios-dam breaks, etc. A community radio station can play a vital role.

APPLICATIONS-There were 14 elders vetted and approved for elder status, at least 8 additional applications need further review/verification. One denial. Application deadline is Feb 1 for this year's fair.

CAMP-Roger and Mambo spoke with the site manager; wood chips are available on site for our use, three trees have been marked as poles for our banner, authorization to fall pine trees given.

BUDGET COMMITTEE-Katie made our request for additional vehicle stickers based on our high percentage of members with state disability tags. Last year many of these people were sent to Domain Merriwhether while parking spots remained unused up front onsite. We were told that we are not to be making special accommodations, the maximum possible number of regular vehicle stickers to qualified elders remains at 50% of total Elder pass requests and are to be filled on a first come first served basis as stated in our Elder's, Operation's and Inventory's Pass Process Agreement. (Plan to review and update this document at the fall retreat) Charlie stated that he would personally deal with those beyond the 50%.

Proposed guideline changes using Miss Piggy's Lot instead of Craft's Lot for altered parking will be discussed at the Feburary BoD meeting as stated in the most recent issue of Fair Family News.

CAPITOL PROJECTS-Jerry S. will write up a request for funds to build a display coffee table for the Still Living Room. He will email info to Katie in time for the 1/26 meeting.

SPRING RETREAT-Alice's is confirmed for our use April 11-12, 2015.
