Parking

Thom – Have not heard back from Branch engineering yet on potential traffic analysis. I went to the site with Charlie and measured the HUB gravel areas and by Alice's etc. Measured those spaces and using the county specifications there is room for 59 spaces at the HUB and 48 around Alice's. That's room for a total of 117 spaces in existing areas. That's a good place to start.

Tom – That's for 300 people?

Thom – according to the county, that would be for over 400 people. There are more spaces around but these are easy.

Jon – It depends on if the county will require us to have parking for the outdoor people. Let's say we have 200 people outside.

Thom, Hilary, Andy et al. – We would need 50 more parking spaces. Could we use Dug's Green? Yes, that would be excellent parking. It's close. The only thing is that it brings people close to the neighbor's residence. That doesn't mean we can't use it.

Jon – People currently use the HUB for other things. Does that mean we have to subtract that out? Thom – You can have a parking lot serve dual purposes.

Thomas – Did you count Zen?

Thom – I did not. I couldn't find out where the septic really is.

Hilary – So that's just kind of a report back of a place to start. It's very encouraging.

Jon – All that parking has been created by people parking there. It's not developed. Is it going to have to be graded and gravel?

Thom – There aren't any standards but we're going to propose something in the application.

Andy – If the parking were in a public area where parking was tight and taking spots away from people.

We have private property with tons of parking. I really don't think the statute is aimed at us.

Kirk – Andy is right. You can make your case for why not to pave. We'll still have to put gravel down though. You can't just park in the mud. I think we'll be able to propose gravel and that will be OK. But areas with heavy truck traffic would require more. And handicap will have to be paved.

Thom – You're absolutely right. The county typically doesn't require paving. We'll propose gravel and they'll probably go for that.

Budget

Jon – I've been trying to get Archeology to come up with some numbers. Tom is feeling like he wants the full scope of the project first. He wants to know the exact location of the drain field, parking and the building footprint. I asked if he could come up with just the footprint of the building to get started. His suggestion was to do a sub-surface testing, basically dig holes. There's too much stuff there to do other methods. Basically Tom and Anna and DJ would like a map. (Everyone on the committee wants a map!)

Thom, Jon, Paxton, et al – discussion about how much grading and gravel would be needed for parking and how much this might or might not impact the archeology survey and thus impact cost.

Jon – In terms of timing it would be good to get the survey done this year so we have an idea if anything is out there.

Hilary – I think we're down with that. I talked to him about doing Alice's down to the HUB and we'll need to do an RFP, but he gave me about 10K as something that might be realistic. It doesn't have to be figured out for next Monday's meeting.

Charlie – It can be a GM line item for things we might need this year. Archeology is already there and I would do that as a budget adjustment. Thom and I are meeting with John Stapleton at Pivot next week (Feb. 6) about the greywater piece, and we'll know a lot more at that point about the cost for that. But a lot of this is going to go through adjustments.

Thom – The county permit application is \$2600.

Jon – Once the permit is in, at what point do we go into Design? Will it happen this budget year? Charlie – I'd like to think it will be this budget year but it's hard to know.

Jon – My question is, the 400K that we have ear marked for the community center, will that be enough to see us through the design phase.

Everyone – Yes. I would hope so!

Jon – My point is that we have enough to go with line item adjustments for this year.

Kirk – I'm trying to think of the things we'll need money for.

Lynda – The items we've identified as potential costs in the past are: Permit application, archeology, septic/water, sound engineer, site plan, traffic/parking. The site plan is for creating the SUP application. I can add another line item for mapping.

Mapping (budget sub-topic)

Paxton – Anna brought the mapping request to the mapping sub-committee of LUMP.

Kirk – It makes sense to me to have a map that includes a tree survey prior to engaging schematic design professionals.

Thom – The trees aren't necessary for the permit application and I'd hate to see it hold things up.

Kirk – Once you're out there we might as well get it done. And we'll need the trees for the parking.

Thom – I'm just concerned about the timing because the mapping we need for the county permit is much less than what we need for the schematic design. We're almost there to turn in the permit for the community center. The parking doesn't have to be that specific. They're concerned about impact to the neighbors. It can be a blob.

Lynda – We decided we would shoot for an April/May timeline for submission of the community center permit.

Paxton - Mapping sub-committee of LUMP has some sophisticated equipment. I'd emphasize to them that we need the community center area data ASAP. We need the map by April and will ask if they can do the trees as well.

Scribe note: Committee later realized that Anna had sent a note saying Jason recommended getting a local company to do this as his company is not local. Paxton will ask the committee for a recommendation.

Hilary – If we're going to tie this back to budget, we probably need a printing budget as well.

Kirk, Jon, et al. – Discussion around having a Design Charrette. Do we need budget for it? It can come out of Board budget. The cost is very minimal. General agreement that we want to have a Design Charrette in the future but will focus on the permit application in the short term. Hopefully by post-fair we'll know if the permit is approved or not and we can start planning the Design phase. Like the idea of having the design session on site.

Charlie – The traffic folks don't think we're going to need a follow up traffic analysis study. Thom – We're going to want to sit down with the county folks and get them to concur that we don't need the further analysis. We'll have the guy from Branch Engineering come with us. We'll pay him something to accompany us.

Thom – I'm meeting with the Sound engineer this week and will get an idea of what it would take to get an analysis out there.

Jon, Hilary – So we don't have anything for sure but we'll do a series of budget adjustments as we confirm what needs to be done and figure out how much it's going to cost.
