
ARTICLES OF INCORPORATION O THE OREGON COUNTRY FAIR A Nonprofit Corporation



I, the undersigned natural person over eighteen years of age, acting as incorporation under Chapter 61 of the Oregon Revised Statutes, adopt the following Articles of Incorporation:

I.

The name of this nonprofit corporation is THE OREGON COUNTRY FAIR and its duration shall be perpetual.

II.

The corporation is organized to promote cultural activities as well as any other lawful purpose, none of which is for profit.

III.

The address of the initial registered agent of the corporation is 1628 East 19th Street, Eugene, Oregon 97403 and the name of the registered agent at that address is Jill Heiman.

IV.

The number of the initial Board of Directors shall be six whose names and addresses are as follows:

No part of the net earnings of the corporation shall inure to the benefit of any private individual except that the corporation

may pay reasonable compensation for services rendered for the benefit of the corporation.

VI.

Upon dissolution, after paying all the liabilities of the corporation, the Board of Directors shall distribute any assets remaining to such organization or organizations qualified as an exempt organization under Section 501 (c)(3) of the Internal Revenue Code.

VII.

The name of the incorporator signing these Articles of Incorporation is Jill Heiman, 1628 East 19th Street, Eugene, Oregon 97401.

CORPORATION DIVISION

The following Articles of Amendment were adopted at a duly held meeting of the Board of Directors of the Oregon Country Fair on the 2nd day of October 1989.

I.

Article II is amended to read:

The corporation is a public benefit corporation, organized exclusively for charitable, educational or other purposes within the scope of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from the Federal income tax under section 501 (c)(3) of the Internal Revenue Code.

II.

Article VIII is added:

The corporation shall have members entitled to vote annually for the election of the Board of Directors and any other matter which, under the terms of Chap. 1010 Oregon Laws 1989, requires a vote of the members. No part of the net earnings of the corporation shall inure to the benefit of any member except as is set out in Article V above.

2. Article IX is added as follows:
