He slowly meandered up the coast, living in Eureka and going to school at the College of the Redwoods for a short time, then on to more adventure and fun.

He landed at a commune by Fern Ridge Lake in Veneta, Oregon, where he met the love of his life, Jude. They created a lifelong loving and respectful partnership. With his big heart, he worked hard so he could spend time with beloved friends and family, mushroom hunting, dancing, listening to the Grateful Dead, and throwing large parties. He loved to cook for all his friends

and family, he loved "a real good time," and most of all he loved community.

He has been a part of the Oregon Country Fair for 44 years. He donated the equipment and set up the refrigeration at the original Chillville, and was booth rep for the "Divine Balance" Organic Fruit Salad booth.

Paul and Jude have two sons - Zach and Cody. Paul was a great father who was always so proud of his children. When he became a father, he started his business of Energy Systems Refrigeration and supported his family. He helped many businesses, focusing on the natural foods industry in Eugene. He helped give many local natural foods businesses a great start by buying, selling, and setting up refrigeration systems for them, often saving costs with re-used equipment. Many of those local businesses are still in operation today.


After 22 years, Paul decided to start a new business, Sweet Creek Foods, on their farm in Elmira. It took seven years for the full transition between the two businesses.



He was an equipment wizard and carpenter who loved food, so this was the perfect match. From the ground up, they built the facility and operated it for many years, based on making quality organic food, until they sold the business in January of this year.

So yes, he retired and passed away soon after. This was not in the plans, but Paul was a Western medical miracle and was born with a defective heart valve. His life was extended with several heart surgeries, starting in his 30s. He literally had a big heart, which he shared with everyone he loved. Paul will be deeply missed by all who loved him, because he truly loved you all.

Paul's parents, Bob and Mary Fuller, passed within this last year. In addition to Paul's wife, Judy, and their sons Zach and Cody, Paul and his parents are survived by Paul's younger sister Patty, who lives in Sonora, California.

Positively Neutral: Do your part! Carpool with Friends!

by your Carbon Neutral Working Group

In 2018-2019, several intrepid OCF volunteers concerned about our contribution to climate change formed a working group to calculate the Fair's carbon footprint and develop proposals to reduce it. This work is supported by a 2019 Board motion to strive to be carbon neutral. The group partnered with Portland State University's Institute for Sustainable Solutions and developed a Phase 1 report that was summarized in the September 2020 issue of the Fair Family News.

Initial estimates place Oregon Country Fair's carbon emissions at 4,500 tons of CO2e, equal to the annual electricity use of 691 homes. The research also found that 97% of the carbon footprint calculated in 2019 is due to travel. The other 3% was primarily from the use of vehicles to service the event and the operation of the Fair's Eugene office year-round.

Travel by crews and booth participants

- Nearly 55% of the Fair's calculated emissions come from an estimated 60,000 trips made by both booth participants and crews pre-, during, and post-Fair.
- This value assumed two people per car per trip, which means that increasing carpooling to three or four people per car per trip would result respectively in 25% or 50% reductions in the estimated carbon emissions from the Fair Family. These trips tend to be concentrated to and from a few metropolitan areas (e.g., Eugene, Portland, Seattle), which provides a big opportunity for

carpooling to reduce single-occupant vehicle trips.

Travel by the public

- Nearly 43% of the Fair's calculated emissions come from the public traveling to and from the event on one or more of the three days.
- Of this travel, between 50% and 65% come from air travel and the remainder from driving.

- Driving assumed two people per car per trip, which means that increasing carpooling to an average three or four people per car per trip would result respectively in 25% or 50% reductions in the estimated driving emissions of public Fairgoers.
- Carpooling with two people, and especially three or four, is more carbon efficient per mile than air travel, suggesting that longer road trips with your friends may be a net positive on the Fair's carbon emissions.

The Carbon Neutral Working Group is planning to conduct a survey this year to obtain more information about travel patterns. For example, many people ride the bus to the Fair. The carbon savings from bus ridership depends on how full the buses are and what alternative that Fairgoer would have chosen if the bus option was not available. In 2023, we will estimate the carbon savings from bus ridership.

A message from the President of the Board of Directors, Oregon Country Fair

Dear Oregon Country Fair Membership,

I hope this message finds you doing well. I want to take a moment to thank every one of our amazing and wonderful volunteers, booth people and performers. I am continually inspired by the passion and enthusiasm that you bring to the Fair each and every year and I am so thankful for your involvement in our community.

I am writing in the capacity of President of the Oregon Country Fair Board of Directors to provide you, the membership, with an update on the ongoing efforts to address concerns regarding the functionality of our Board and Diversity Committee. As president of the Board of Directors, I have received hundreds of correspondences expressing concern regarding the performance and health of both the Board and the Diversity Committee. I have spent the first few months of my tenure on the Board quietly listening.

As a nonprofit organization with a specific mission: to create events and experiences that nourish the spirit, explore living artfully and authentically on earth, and transform culture in magical, joyous, and healthy ways, we have a unique responsibility to promote equity in all aspects of our work. This means ensuring that our policies and practices are fair and inclusive, that we prioritize diversity in our hiring and recruitment processes, and that we actively work to dismantle any systems of oppression that exist within our organization. It is also important that we all examine the ways in which our own biases and assumptions might be affecting the work.

Unfortunately, over the past few years, we have experienced dysfunction within segments of our Board and Diversity Committee. There have been significant concerns expressed by membership regarding the overall communication, accountability, and decision-making processes of both the Board and the Committee. Our work as a Board and a Committee is almost entirely public in nature, as it should be in a nonprofit organization with a large membership. It is clear in reflecting on past meetings and interactions, that personal conflicts and unprofessional behavior have interfered with the ability to be productive and accomplish important work on behalf of the organization and membership, which is our fundamental responsibility. As Board President, I take these concerns seriously and am working to address them to ensure that internally our Board is operating effectively and professionally and in alignment with our organization's values and mission, and that our Diversity Committee has effective guidance from our Board. It is also my intent that our work is transparent and membership is informed of our progress. Your feedback is critical to the health of our community.

Disagreements and conflicts are a natural part of any group dynamic, but it is how we handle these conflicts that determines our success. We have not been handling these conflicts satisfactorily. I want to express my disappointment in the disrespectful language, personal attacks, and disruptive behavior that have occurred during some meetings and on social media. This behavior not only undermines the effectiveness of our work together, but also creates a toxic environment that is damaging to the well-being of our members and our organization. These behaviors are also violations of our code of conduct.

As leaders (Board and Committee members) of this organization, it is our responsibility to model the values of respect, civility, and constructive dialogue. We must be

able to have open and honest conversations about difficult topics without resorting to personal attacks or disrespectful behavior. Our work is crucial to the well-being of our organization and the individuals we serve, and it is essential that we approach our work with a shared vision and a commitment to collaboration.

It is important that we establish measurable goals and objectives for promoting diversity and equity within our organization. These lead to actionables. By setting clear objectives, we can hold ourselves accountable for progress and take action to address any areas of improvement. Currently this work is not happening. It has stalled.

As we move forward, I encourage all Board and Diversity Committee members to reflect on their roles and responsibilities and to renew their commitment to our shared mission. Our work is too important to be hindered by arguments, personal conflicts, and inaction, and I am confident that we can overcome these challenges and achieve our goals if we work together with respect and cooperation. I also urge those that cannot overcome these challenges to find other avenues of volunteering at the Fair.

Although we have done work on these issues (had DEI trainings for the Board and coordinators, diversified our Board and staff, and created safe spaces for marginalized communities at the Fair, for example), we recognize that there is still significant work to be done. We are committed to continuing that work together as a community. We value your input and participation, and we encourage you to share your thoughts, concerns, and ideas with us as we continue on this journey.

Thank you for your continued support of our collective mission and vision. We are much stronger together.

Spirit of Transparency

In the spirit of transparency, I am sharing the following letter from Mauricio Valadrian, a DEI consultant and facilitator (https://valadrian.com/about). Mauricio was hired by John Alexander and me, the Board Liaisons to the Diversity Committee, to facilitate a meeting between the Committee and the Board. Here's a short timeline of that process.

At the Feb 18, 2022, Board meeting the Board promised a facilitated meeting between the Board and DC.

"The OCF Board continues to value collaboration and will engage with the Diversity Committee in a facilitated process to establish a working relationship to further the work of diversity, equity, inclusion, and transformative justice."

On April 13, 2023, Mauricio was hired.

Tom, John, and Mauricio set a date and found a location for a hybrid meeting. When the date wouldn't work for enough people Mauricio added two more dates.

On April 19, 2023, although no meetings had been held, Mauricio received numerous emails and calls from participants. Mauricio then stated that because of the dysfunction he encountered, he could not do the work and sent us the following letter:

Muy buenos días.

I'll preface by making you all aware that I've never attended the Fair, and any knowledge I may have of it is tangential and superficial at best. When I was first approached about the possibility of facilitating a conversation, I thought that dissociation would make me a strong candidate to navigate a conversation about rebuilding

co-creation tools around shared foundational goals.

If I were to make any observations based on this communication stream, it would challenge every assumption I have made about the nature of the Oregon Country Fair, and more so about any aspiration in regards to Justice, Equity, Diversity, Inclusion, and Accessibility. Certainly it has not felt like an invitation to discover the near-magical experience that had been at some point described to me.

I find it particularly tragic given that this group has direct access to lived experiences from nearly every corner of the human spectrum: Black, White, Brown, men and women, First peoples, Multigenerational wisdom, Neurodiversity, differently-abled folks, LGBTQIA+, many with notable academic formation in fields related to health and wellness ... and all of this wealth ... devolved into mud slinging that quite frankly feels indistinguishable from the political circus in the social media exosphere.

I'd like to make clear that I do not minimize harm, trauma, or re-traumatization. I escaped murder from my home country torn by civil unrest, unlike many of the folks I grew up with, and have experienced a fair share of palpable (not implied) discrimination here in Oregon as an illegal immigrant and having English as a second tongue.

That is why it's so alarming to me that in this email thread, that is less than four days old, I've read how there may be active or potential discrimination against folks in the immunocompromised and differently-abled community, emotional abuse, personal and collective safety at risk, cyberbullying, hate and racism that puts families of color in peril, vilification of elders. It may be worth exploring if it IS truly an adequate characterization of the inter-group relationship dynamics, and if so, how much is it hindering the very mission to which each of these confronting entities are bound, and the work that protects the interest of the larger community.

I feel that impermeable walls have been built around the possibility of civil discourse between members of this group, brought about by personal attacks (direct, interpreted, or implied), and the process of deconstructing them would be very time consuming and complex as some of you have already expressed. And while I think that the specific process is a worthy and necessary healing effort, I also believe that it would cater more to the disputing parties rather than the whole, and may address only the morphology of the issue and not necessarily its substance. I would highly encourage seeking independent personal conflict resolution to avoid unnecessary entanglement with committee and board service.

This is why as many of you have already stated here, and some through direct communication with me, this is far more than a four-hour conversation could achieve, though in full disclosure, the intention always was to just open the door to re-centering around common goals based on empathy and compassion, and give the relationship between parties a chance to reset. That is restorative work with which I am most familiar, though given the nature of this exchange, I feel inadequately equipped to take on relationship forensics and that variety of conflict resolution, and so am recusing myself from it.

I thank you all, and I wish that the Fair, and all that it represents to each of you which fires up the passion and the conviction to keep showing up, may become that beacon that shines on a heart-centered path forward.

I very much support this follow-up to the December 2021 motion to incrementally raise the elder qualifying age from 55 to 60 with an approach worked out between the Budget Committee and Elders.

I'd like to thank Sandra for attending multiple Elder's meetings, and the Elders for their attention, research and feedback.

I think the method suggested meets the original criteria of being gradual.

Managing our growth is such a big change for us. The conversations that the Budget Committee and staff have with affected folks are new to us—and often hard. The approaches we have taken are to make efforts to make many incremental adjustments, as opposed to making radical changes. Nonetheless, changing from a mentality of how we have always done it, and just adding a few more people is okay—that is a big change.

Do not Sustain Bad Practices

Hi Everyone,

Spring at last, 65 days until the 2023 54th Oregon Country Fair.

Late Monday night I watched the Fair Board meeting on YouTube. I was so disappointed and saddened. There is palpable tension, distrust, lack of good will among Board members.

One example was a minority faction, led by Jon Silvermoon, defeating an innocuous housekeeping Bylaw change to require the President and Vice President of the Board to be elected members of the Board of Directors. As it is now, those Executive Officers do not have to be elected to the Board, but can be anyone who can get the votes to win among Board members.

These officers are the highest authorities of the Fair and must be trusted leaders of vision and conciliators. Of course they should be held accountable to the Membership! Fair attorneys, Fair nonprofit consultants, Fair Bylaws Committee; Fair work session participants/ members; Fair Executive staff all agree: change the Bylaws to require the President and Vice President be members of the Board. No other membership nonprofits allow non-Board officers.

It is not good organizational governance to sustain a bad practice. This outcome keeps the option for the Board to install non-members on the Board, and preserves the possibility of manipulation.

The faction was able to defeat the Bylaw change with the "2/3 must vote yes to pass" voting requirement of the Board. So with 11 people present, 4 people voting "no" blocked the passage of the motion. A small minority took membership rights away from us. That is wrong. We should all be concerned this could happen with impunity. This Bylaw change can and should be brought back for reconsideration. Please speak up.

It's been too long since Board meetings had a glimmer of joy, a sense of working towards the same goals or gratitude. Love,




JHVF Grants Boost Environmental Sustainability

- Centro Latino Americano will offer programs and workshops such as seed-saving and basket-making through its Líderes (Leaders) program in the Organic Community Garden. The program helps participants develop leadership skills and build a support network as families learn to grow, harvest, and process organic food.
- Community Supported Shelters will install greywater filtration systems to provide an environmental approach to wastewater in their Safe Spot Communities. CSS is working with the University of Oregon's Landscape Architecture and Environmental Studies to build the four-planter filtration systems.
- Looking Glass will purchase tools and gear for the Lane-Metro Youth Corps for projects that will restore natural resources around Lane County.
- Northwest Center for Alternatives to Pesticides (NCAP) will boost awareness of communities impacted by pesticide use through a media campaign and radio show outreach.

Heidi: The Bylaws committee has been meeting for a long time and is happy to present proposals now. There are 11 sections of the Bylaws. They are just recommendations, being brought to the Board to suggest changing.

Letter from the Committee

On May 24, 2019, SB 360 was signed into law, which amended Chapter 65 of the Oregon Revised Statutes that govern nonprofit organizations in Oregon. The Act became operative on January 1, 2020.

At the November 2, 2020, Board of Directors' Meeting, the Board unanimously approved the motion directing the Bylaws Committee to perform a comprehensive review and update of the OCF Bylaws.

The Bylaws Committee began to meet on the third Tuesday of each month to take up this Board directive. We created a work plan and started a spreadsheet containing the current Bylaws on the far left column, a column to the right containing links to the relevant ORS 65 statutes, and another column to the right of that for committee suggestions for language changes.

Over the following two years, the Bylaws Committee has met regularly to continue this work. In February of 2023, we submitted our draft to the attorney for feedback, and received that feedback on March 8, 2023.

The committee met on March 21, March 28, and (will meet on) April 6, to process the attorney's feedback and draft our final recommendations to the Board. A Board Work Session has been scheduled for April 17, 2023, at 7 pm for the purpose of reviewing the recommended amended Bylaws. The Board and the membership will have the opportunity to review the work of the Bylaws Committee, ask questions, and make recommendations.

Prior to submission of the final draft to the Board for approval, the draft will undergo final attorney review to ensure that the amended Bylaws are sound and comply with the most recent ORS 65 statutes.

Article I: NAME, OFFICE, MAILING ADDRESS

Instead of saying Corporation, use OCF

AJ: What problem was this solving?

Heidi: Simplify the language

Article III: DATE OF THE FAIR

Use "Fair" instead of Oregon Country Fair Annual Fair Event

AJ: There are lots of Fairs.

Lawrence: "Fair" will refer to event. OCF will refer to the legal corporation. Legally it's more in reference to the Bylaws.

Article V: MEMBERS

Jon Silvermoon's comments were emailed, and Lisa read them aloud: "If we are going to recognize two classes of membership, I think there needs to be a clearer definition of what it means to be a Charter Member, including eligibility requirements, rights and responsibilities, and method to rescind membership if there is one. It should also be made clear that whenever the phrase "membership" is used in various clauses if that refers to both classes or only one. If we are going to recognize two classes, I think we should go slow in doing so.

"If Charter Members are entitled to repayment of promissory notes upon dissolution of the corporation, are the sum total of those notes liabilities that should be carried on our books? "Does anyone know that total?

"Can Charter membership also be terminated in accordance with article V, section 5?"

Sandra: Good job distinguishing Members and Charter Members, but Charter Member seems to hinge only on pay back of a promissory note. Has anyone seen one of the Promissory Notes?

Lisa: Charter Members already exist in current Bylaws. Attorney pointed out that if we have Members and Charter Members, then we do in fact have two classes of members. If Board decides to keep Charter Members in, then this language would be needed.

Paxton: Knows of booths at the Fair that still have Charter Members. Believes they should take Charter membership status out of the Bylaws, but not sure how to do it. Twenty to 30 years ago, there was an effort to figure out who OCF owes money to, but nobody could find a list of donors or loaners of funds. Thought he recalled they used to get first choice of booth space, but that seemed like the only residual honor. He thinks there should be a way to honor the Charter Members who helped create the Fair by donating money.

Palmer: Thinks he recalls people could be repaid by choosing new spot from leftover spots after Old Fair booth day and New Booth Fair day.

Grumpy: Long ago, he had responsibility of giving charter documents to Charter Members. He will scan a packet and send to Office, so it can be distributed to whoever wants it so they can understand what a Charter Member is.

Arna: Former attorney felt strongly that there was only one kind of member.

Heidi: While Membership Secretary, I was given a list from Robert DeSpain of Charter Members. Mysterious star by some names.

Sandra: Bylaw is specific about a promissory note, so if people are not in possession of a Note, they should not be able to expect repayment. Grumpy has copies of Promissory notes. They basically say that if the Fair owes them money and the Fair has money, they can ask for it.

Lisa: Bylaws refers to "upon dissolution" then Charter Members with Promissory notes would be paid.

Heidi: Maybe ask lawyer how they can come up with language to cover both types of membership as single type of membership.

Arna suggested that we scratch all Charter Members and just have the language about "upon dissolution" that you get paid back upon Dissolution.

Lawrence: Talked about this at Committee and they all believe there is only one kind of membership, but in effect there is a second kind of member; Charter Members will eventually be gone. Language as proposed is fine now and we can eliminate this language when they disappear.

Grumpy: Everyone should look at the documents before they decide because they do have promissory notes and certificates.

Article VI: MEMBERSHIP MEETINGS

Lisa read Jon Silvermoon's emailed comments: "Article VI, Section 2 Special meetings is a little confusing. I think it would be better to separate into two sections: Special meetings called by the Board and Special meetings called by the Membership. For the former, I assume the Board sets the time and place while for the latter the Membership Secretary sets the time and place. It is not entirely clear from this article as written if that is indeed the case."

Special membership meetings

Sandra: Same kind of meeting, so not sure distinction is needed.

During Recall or Removal Petition- Bylaws prevented the Board from being able to have a Removal Petition voted on during elections. Later heard that we might have erred in saying that; it just needed to be on the agenda to meet the criteria.

Article VII: THE BOARD OF DIRECTORS

Remove coordinators and fix language a little bit

Sandra: Entering into contracts. The Board hired a consultant recently. Is this clear enough to separate Operations from Board Business? The Board won't be entering into very many contracts.

Lawrence: If Board wants to retain any power to enter into any contracts, the language needs to be there.

Paxton: Brought this up when reviewing document, but they were wrapping up. Maybe Board needs to talk about it. Thinks it needs more work and discussion, but maybe in another setting.

Kirsten: Can think of numerous contracts the Board might want to enter into. They might want to hire contractor to review ED. If no ED is working, this will keep the Board empowered to have ability to enter into contracts.

Lisa: Charge was to review Bylaws to bring them into compliance. Board definitely needs to retain ability to enter into contracts.

Lawrence: This is the value of Work session — fulfilling mission set forth by Board and then discussing issues.

John Alexander: Regarding LT noting additional things that might be considered, will this committee have a list of items to look at in near future, since they're doing deep dive?

Lisa: A list could be provided if desired.

AJ: Is the committee recommending these changes at this time based on trying to meet a mandate or is there much more work to be done and possibly this is being rushed to meet a mandate?

Heidi: They've been working for nearly two years, so don't feel like they're rushing. They'd like the bulk to be brought forth now and recommended to the Board. Yes, someone should be keeping a list of what the Bylaws Committee should look at next.

Lawrence: Committee works at direction and pleasure of the Board.

Arna: Has been liaison to committee for sic months and has seen that they do incredible work. They are talking about policy issues that they cannot decide, only bring to the Board.

John Alexander: Think it's great and doesn't want to delay because there are other things to be done, but he would like to see other general recommendations.

AJ: As we go through these recommendations, he's hearing that more guidance might be needed, and more questions might arise. Maybe we shouldn't rush anything and spend time. How do we plan to bring this to the Board? One by one or as a complete package?

Lisa: Committee has been elbow-deep for over two years. Don't feel like they're rushing. Been doing good job of sticking to their mandate and being methodical and systematic. Maybe the Committee can write a report at the end and propose to the Board to see what their next charge might be.

Grumpy: Committee has been working for over two years and it's close to being done. How it will be presented to the Board is in the current Bylaws, whether one-by-one or package deal. Time to go forward. Current Bylaws tell us how to Amend and how we can discuss at Board meeting.

John Alexander: Lisa's suggestion was great, agrees with Grumpy but wants to get this done. Encourage committee to finish their charge, and then compile the list of future ideas to explore.

Special meeting called to remove a Board Member- dictated by ORS Statute

Stephen Diercouff: Attorney said that a meeting needs to be called for the purpose of removal, but other items can be on the agenda too.

Sandra: So other items could be covered at that meeting, but at Annual Elections meeting, that meeting already had a special purpose, so couldn't be combined with Removal action.

Stephen: We could have two meetings on the same day. Removal actions are uncommon.

Article VIII: MEETINGS OF THE BOARD OF DIRECTORS

Emergency Meetings

Sandra likes the fix.

LT: Committee labored over imagining circumstances. Reached out to people most likely to understand what that might look like on the groun, BUMS.

AJ: General question as we transition from one item to another. Did the Committee consult a consultant with an equity lens to look at the recommended changes?

Committee didn't reach out to consultant due to needing a contract, but they did specifically discuss looking at Bylaws through an Equity lens (DEI lens). Looked at DEI consultants reports as well as Mary Miller's report to the Board. Some Committee members researched other organizations to see what kinds of equity ideas they included in their Bylaws

AJ: Wants more specifics — what other organizations did you look at?

Lisa: Looked at Report and recommendations from the DEI consultants that the Fair hired to see if anything was applicable to Bylaws. Looked through NAO recommendations to see if anything there was applicable. Researched other Bylaws of organizations that members are involved with. Ann and Dianne?

AJ: Board hasn't discussed Consultant recommendations yet...What item was affected by the DEI lens?

Heidi: Only section where DEI might have affected Bylaws was "Purpose" and that's bigger discussion than the charge was.

AJ: Meetings, how membership meetings happen — marginalized people might be affected by the way meetings are held. Need a better answer to the question of how a DEI lens was applied.

Article IX: OFFICERS

Lisa read Jon Silvermoon's written comments: "Language is added to the duties of the Membership Secretary 'to be a member of the Elections Committee to ensure fair and accurate

elections at annual and special membership meetings.' If we are going to reference the Elections Committee here, then earlier in the Bylaws we should establish one as a standing committee rather than simply stating that the Board may establish one. Also, it is not clear by this language if the Membership Secretary has the authority to make election-related decisions on their own or if they are just a member of the committee that makes those decisions. I think it should be the committee to which the Board has delegated that authority. Concerning the recent recall election, I on several occasions asked who or what body was making the decisions concerning the conduct of that election and under what authority each decision was being made. I never got an answer. We need to have clear language in the Bylaws about this."

Sandra: Why would asking them to join the committee need to be in Bylaws? Jon has a point but maybe it doesn't need to be in the Bylaws.

Heidi: So Board doesn't have to approve new officers.

AJ: Agrees with Jon on this one. Not too much for Board to appoint officers to the committee.

Heidi: Maybe it does make sense to just make committee a standing committee.

Stephen: Membership Secretary needs to be on committee for them to do their work. One less bit of housekeeping. Fine either way though.

John Alexander: Likes idea of standing committee. We need to ask ourselves what policies we need when Bylaws are not needed.

Lawrence: Didn't think about standing committee, but it seems pretty obvious now. Interface between officers and committees is quite clear. Need to codify standing committees that exist.

AJ: Could there be confusion because there were two Secretary positions and currently one person is doing both?

Heidi: There used to be two secretaries — Recording and Membership. Want to clarify separate responsibilities.

AJ: Both secretaries should be on both committees

Heidi: Board probably won't have package to vote on for at least two months. The committee will present to the Board and then they will take recommendations for further revisions and then back to the attorney.

Article X: TRANSACTIONS

Transactions vs. Contracts -2/3 of Directors

John Alexander: There was confusion recently about conflict of interest. The Board should consider a stand-alone conflict of interest policy.

Lisa: ORS requires us to address conflicts of interest. Jon S. comments summarized — He thinks we should keep contract language in there. How the OCF defines conflict of interest can be more expansive than minimum state law. Proposed changes dilute current standard, and he's not in favor of that.

LT: Every contract is a transaction, but every transaction is not a contract, that's why attorney suggested this new language, disagreeing with Jon S.

John Alexander: Agrees with LT but hopes we can address Jon S.'s concern with a standalone conflict of interest policy.

Sandra: Well-written Bylaws are general concepts, not how-tos. That's what John Alexander is asking for— a policy.

LT: Agrees with Sandra. Bylaws are like a constitution, not statutes.

Heidi: Thanks to attorneys for all the language. Thanks Lisa and Kimmo.

Article XI: AMENDMENT

LT: Members' right to vote can't be taken away except if they vote to remove that right. Is the term "relative" defined by law so we don't need to quibble about it?

Heidi: This is what the lawyer came back with.

Lisa: Committee next steps are to take feedback and review at next meeting — go to lawyer again and then back to Board.



Jon Silvermoon proposed that Committee Meeting notes should not be included in Board minutes because they were not discussed at the meeting. John Alexander offered that other boards have a motion to approve all regular committee minutes; maybe we could include a regular agenda item to do that. Jon S. proposed a friendly amendment to put an addendum to add committee notes at the end of the minutes. AJ said that he would like to vote on the motion as is because this is how we've been doing the minutes for a while now, including the committee notes.

Jon S. moved to amend the motion to include committee meeting reports as an addendum. Ann seconded.

Ann said there were meeting summaries that had not yet been approved by the committees, putting the Board in an awkward position. Per a Board motion, I am reporting progress to date as compiled by Vanessa and Dean Middleton: We're still waiting on Northwest Youth Corp to open for business before making final recommendation to the Board. It's likely that hybrid meetings won't happen until after the 2023 Fair.

Administration

- The on-site coordinator meeting on April 16 was well attended. Lots of information was exchanged. The next meeting is June 4 at 2 pm at Alice's Fire Pit. Staff T-shirts will be available for pickup.
- There will be no fireworks this year on the Fourth of July. Next year, with the shift of the event to July 12-14, festivities may return.
- Ticket sales are on par with previous years. Three-day tickets are sold out. We are approximately 30% sold out.
 - Entertainment lineup was announced Thursday, April 20, via a social media blast.

What the Board did in December 2021 was ask Budget committee to work with Elders Committee to move Elder age from 55 to 60. Sandra has been at a lot of meetings. The Committee did a lot of research and had a lot of conversations. There are a lot of capacity conversations in various groups to accommodate growth. We need to get good information about the ages of our membership and when Elders may graduate. There was an assumption that the number of Elders would even itself out but it's not happening; instead it has doubled in the last 10 years. It's the only program we have that has unlimited growth. We need to slow the growth and remind people that we can't disproportionately affect our growth as a Fair.

New Business

Committee Best Practices Work Group — Manual Revisions Recommendations (Arna & Sandra)

The Committee Best Practices Work group recommends the following Best Practices' manual revisions:

1. BOD Liaison Role

"Committee Facilitators and Board Liaisons are responsible for ensuring that all present at committee meetings adhere to the Code of Conduct and will set and ensure that each member of the committee and other individuals, whether present or absent, will receive respectful and equitable treatment."

2. Closed Committee Meetings

The purpose of Board committees is to provide information and recommendations to the Board, and in that role closed meetings should be rare and only used when absolutely necessary. All committee, subcommittee, ad hoc and work group meetings of OCF Board appointed committees are open to all Fair members with certain exceptions, as described below. All criteria below apply to committees, subcommittees, ad hoc and work groups. Any Director may attend any closed meeting.

Process and criteria for a closed meeting:

The OCF Board of Directors may request by a motion that a committee address a topic requiring confidentiality.

Any committee or subcommittee wishing to hold a closed meeting must request and receive prior approval from the Board liaison(s) and Board President and provide notification of their intent to hold an approved closed meeting, including the reason, date, time, location or link, and agenda to all members of the OCF Board of Directors not less than 7 days prior to the planned date of the meeting.

If a closed committee meeting is planned to occur in the context of a meeting at which topics that are not eligible to be discussed in closed committee sessions are also on the agenda, the agenda items to be discussed in closed session must be clearly marked as closed and arranged within the agenda in a sequence that consolidates the closed topics in a contiguous section of the meeting prior (to) or after the primary agenda topics.

Permitted Topics for Requesting Closed Meetings

- Legal, personnel and real estate
- When an approved Board motion allows for a committee closed session.

3. Committee Annual Report

The purpose of the annual report is:

Provide the Board and others with succinct information of the committee's work.

Ensure the committee is meeting the committee's mission as identified in the original Board motion that created the committee.

Committee Annual report to the Board and membership

An annual report shall be submitted to the Board and officers by date chosen by each committee and annually thereafter. All accumulated annual reports shall be submitted to the staff no later than March 15, to be included in the April Board Packet.

Committee Annual reports shall be posted to the .net site after Board approval.

Liaison(s) Role: Liaisons are responsible to assist committees to provide their annual report in a timely fashion.

The annual report will include the following information:

- Committee name.
- Approved committee mission statement and additional directives.
- •List chairperson(s), officers, facilitator, scribe, and liaisons.
- a. Voting members.
- b. (Optional) years of service on the committee.
- Confirmation that minutes are posted on the .net site.
- •Summary of work performed.
- •Work plan for the coming year.

Elders Eligibility Work Group Recommendation (Sandra & George)

The Board moves to approve the Elders Eligibility Work Group recommendation for the process for raising the Elders eligibility to age 60.

We recommend a 10-year plan that would gradually increase age of eligibility every two years, over a 10-year period. If implemented now, an applicant would need to be at least 56 years of age for the 2024 and 2025 Fairs. They would need to be 57 years of age for the 2026 and 2027 fairs, 58 years of age for the 2028 and 2029 fairs, and 59 years of age for the 2030 and 2031 fairs and 60 years of age from 2032 and after. No one is delayed longer than one year till age 60 is reached.

Potential elders with health issues that interfere with their ability to perform their volunteer duties from 55 to 59 years of age would be eligible for the compassion pass program managed by the ED. The passes would be paid for at the same rate as the Elders passes. There would be a yearly application for compassion passes and they are eligible until the age of 59 as long as they cannot perform their volunteer duties. A compassion pass would count as part of the 20 years needed to become an elder. Medical records or doctor referrals are not required.

Dani Derrick: Al did a great job with the constraints, but the meeting could be managed a little better if the tools of Zoom were used, such as comments and hands being raised. She is

disappointed in the vote today and believes the President and VP should be duly elected. Thanks, Arna, for bringing it forward and hopes somebody else brings it forward again.

LT: I apologize for misuse of meeting chat. Thanks for the reminder of limitations of using it. I want to assume good intentions of Board members. All Board members should be respected despite differences.

John Govsky: I thought the meeting went smoothly compared to other recent more contentious ones. Not sure about Zoom chat rules. Why not use hand-raising feature instead of chat to see order of raised hands? Maybe there is a misunderstanding about how it shows the order of who raised hands in which order and that is why it's not used?

Al Ullman: Chat feature is encouraged in YouTube rather than Zoom.

Jonathan Pincus: We won't be getting to several important items but hopes they will be held at the next meeting as Old Business and featured prominently on the .net site.

Paxton: He apologized for coming in and out of the meeting. He had to change computers midway through. Thanks for a good meeting.

John Alexander: Thanks Al for the amazing grace and tone that he brings to the meeting.

AJ: Thank membership who showed up tonight and every month at these meetings. I try not to sugar coat things. I apologize to the membership for continuing to be a divided Board, which might be filtering into Committees as well. Doesn't believe Board members are all bringing good intentions to the Board, after having watched a discussion about whether or not the N-word should occur at meetings for three months. Next election cycle you should remember when you vote. The meeting went like all the other meetings go, unbelievable that I didn't get to finish what I was saying. Jon Silvermoon interrupted with a Point of Order and then both were muted by Al.

Sprit: Agrees with what AJ just said. Aaron Kenton said there should be discussion at the end of meetings because membership doesn't understand what goes on behind closed doors unless a Board member shares. Al- you did a great job but would like to see some Robert's or Roberta's rules of order. Would like to see gratitude to Staff who are doing amazing work in challenging circumstances. Thanks to Lynda and officers for all that they do.

Arna: It was distressing having Al mute AJ and she hopes she never sees that again. Maybe we need to build time into the agenda for sharing opinions.

Lisa: The Board passed a Board policy to give Facilitator permission to control the room, so Al has the right to control the room. Lily may have muted people during contentious moments.

Paxton: Invitation to come to Board Listening session on Code of Conduct because this is the type of discussion they have been having, about how to deal with this type of behavior.

Jonathan Pincus: When Board Members are speaking, it's a little different than general membership discussions, so they should be able to make statements within a reasonable time.

AJ: In two years he has heard many personal attacks against himself that weren't muted. The 'n' word has been used and those people were not muted. Having his voice muted is very hurtful, especially after all the comments that have been made. This shouldn't be tolerated in an organization that claims it wants to be anti-racist. Al apologized and said he was trying to stop people talking at the same time, but AJ said that he had the floor and Jon Silvermoon was speaking over him so only he should have been muted.

LT: Muting was inappropriate. The Facilitator should have decided about the Point of Order before continuing. When a Point of Order is raised, the speaker should have stopped so the

Facilitator could have made a decision. Everyone deserves the assumption of good faith, which is not bullshit, no matter what anyone says.
