Announcements:

- Katie gave a quick report on how the phone calls to newly approved Elders have been going. So far it has been an enjoyable experience. The rate of returned calls was very good. People really wanted to talk. It was very positive.
- Chewie gave an update. He was asked months ago to go through a process of mediation. He met yesterday with people from Cedar. Cedar communicates with the Fair. He feels very positive. He would like to get this done in a timely manner so that he can get his pass as an Elder.
- Kevin Levy won't be here tonight he is currently on the east coast.

Approve September 2023 minutes.

Nancy made a motion to approve draft 3 of the September meeting minutes with one minor correction. One of the names listed under Elder applications up for is misstated as Drew Minor. The correct name is Drew Miles. Mouseman seconded. The minutes with correction were approved 4-0 with 1 abstention (Heather abstained as she was not present at the September meeting. Eric was not present for the minutes approval).

Archival Request for old Peach Pits – Jenny & Roberta

(7:49 p.m. Eric N. arrived)

Entertainment does not have a coordinated database which makes it very difficult to vet performers' applications. For this reason, they are putting out a call for old Peach Pits.

Roberta said that Jerry Joffe does have archived copies. It would require making an appointment. It was mentioned that some entertainers receive a day pass. The basic criteria for a person applying to become an Elder is, did the person contribute to the fair? Does it need to be a camping pass?

The idea was expressed that it doesn't matter whether an entertainer has a day pass or a camping pass. The bottom line is that they contributed to the Fair.

Jain emphasized that it should be on the applicant to "PROVE" they participated.

People who get day passes are workers, so they are considered volunteers. Assume anyone listed as a performer in the Peach Pit has a wristband.

Bylaws say that if you are eligible to vote in the Fair, you are eligible to count that year towards Elder eligibility.

Village David shared that when he meets newbies, he mentions to them to be sure to document their participation.

- ✤ We could sell T-shirts.
- ★ Why doesn't Events Subcommittee consider taking on the T-Shirt task.
- ✤ Pass the Hat
- ★ If you are raising money within the Fair family, you don't need to worry about the legalities. As a non-profit, if we are only soliciting fair family, we're o.k.
- ★ If you did something like the Village did at Cosmic Pizza (now Whirled Pies) many years ago, raising money for Elders in that way would be okay. The winery is not set up for doing events.
- ✤ Whirled Pies is a great place to hold an event.
- ★ Keep the name Fair Elders if you are raising money at an event.
- ✤ Eric is willing to do a small music benefit.
- ✤ A not-naked calendar
- ★ A senior homecoming dance as a fundraiser.
- ★ A dance event would be a good opportunity to get photos for a calendar.
- ✤ Invite folks on the listserv to contribute suggestions.

SIDE BAR: Elders should document the history of Cahoots before that history disappears.

Decision log needs updating - Carolyn

The last time the Elders Decision log was updated was around 2010. (Scribe's note – upon further research after the meeting, the latest entry on the decision log is 10/27/16. Michael JamesLong kept the decision log up to date from its inception through October 2016).
