Concern about community agreements. Community agreements need to be stronger, measurable, clear. Otherwise equity and access impacts story

Should be the person obtaining a sound permits responsibility to talk to neighbors and form agreements as camp hot. Hard time finding who/when sound permits. Difficult to communicate w stages without that info.

24 and 48 hours are not long enough for camp hosts to find where it is happening and engage in neighborhood agreements.

- Must post permit on venue- must be easy to see w contact info.
- Added the verbiage "sponsoring groups"
- added routing info (security is a big share of responsibility around enforcement, also BUMs- looking for higher level of enforcement)

Task force member initial input

Elijah

Appreciation for the gathered Data

Mostly asked people how the permitting process went for them. Did they have a permit, or not. If so/not so, why? Did they know about permits/how to obtain one?

Sara

Observations were a week prior

Surprised at how quiet pre fair was

Thursday night went out. There were a lot of music sources on the 8. Stages seemed to be contained well. Could not hear too much noise outside of the stage areas. Everyone seemed to be trying hard to be respectful.

Kyle

Trying to pay attention to the roving sound. I noticed a lot more of it this year. Lots of radios, boom boxes, competing sound. Sound engineers were paying attention to decibel reading/ trying to stay within the lines. Could hear clean audio mix, and consistent controlled space. Tried the conversation at a distance trick and was pleasantly surprised.

Shavek

New to fair, I was not sure what I would be facing...

Started off being objective,

When I was in a place, what was I hearing, and was the sound I was hearing appropriate for the place I was in? GPS tag and timestamp added to notes.

What made people feel comfortable?

What was their reaction?

Paxton

Paid attention to pre/post fair parties.

Felt like they were mostly respectful

Used the "can you have a conversation" trick and was able to at every party. All seemed to shut down on time

Dr Dan

Looking with a more attuned eye was fascinating.

We need to work on adhering to the policy we already have

David Adee

Couldn't sleep sao wandered around.

Took notes and entered them into the form.

Would wander from 10 pm- 6 am.

Go from Xavanadu to the 8, and measure how far we can hear the sound.

Wandering sources are not wandering, they are staying in xanavanadu.

Did not engage with anyone, just tracked sound.

Almost all the sound I was monitoring was not permitted. Between 1A and 6A there isn't any permitted sound, but in Xavanadu there was sound all night. Someone said they were scheduled at 3A.

Meg

Time Slots were adhered to

Sound was respectfully done

Some didn't know about permits

People seemed receptive to turning off sound once they were approached and informed about permits.

Lucie

Wandered all night cause I could not stay in my booth- too much noise Sound affected my personality the next day.

Stayed in the lower part of the 8. Some beautiful music, some louder.

Specific quiet areas, and specific high noise areas.

I agree that it may have to do with sound and space, size of space.

Are the permit agreements being enforced?

Joolz

More aware of sound now that I am involved. I took in the sound permits. I had to shut down my first party. I was given a folder of all the previous sound task forces. Got deep in the amplified sound world. Tried to meet all of the people applying for permits in person.

Tried to impress on everyone community agreements. Foundation of amplified sounds will start with community agreements.

We push boundaries. We are here to create something that works better. If we have better community agreements we can at least have something that works to help us navigate this.

Lily

Permits were approved till 2 AM. Everything was supposed to be off by 2 AM. so anything after 2 was not permitted.

All of our internal dialogue will remain internal. We will scrub the form for all identifying info before sharing the public portion.

Shevek Initial Feedback

Captured GPS position Data and had the ability to make notes wherever standing.

Thing I love the most is, imagine for each comment made tonight, there was a timestamps and GPS location for each comment.

Position and ability to timestamp location.

Calibrated SPL meter logging at 1 second interval.

Sound recording that should be able to reconstruct and determine whether it was Bass traveling or what.

Crossover between objective and subjective data

Never went inside the stage area.

Tried to circle around the outskirts. Where sound was being projected.

Called out in notes that equipt upgrade is recommended for a couple set ups, but others were clean and within safe reading.

There were also some surprising speaker directions that did not make sense.

Questions:

David Adee

Thumping BASS is a category all on it's own.

Shevek

Monitored A weighted this year and next year will be flat recording (C weighted scale). Better to track BASS.

What the impact of a particular sound is.

Sleeping people are impacted by different sounds than conversing people.

David

BASS is most destructive to sleep

Shevek

It is designed to trigger the body in that way.

Lucie

Echo the thumping is why i could not stay at my booth

Paxton

Can we map our borders with this data?

Shevek

The only challenge is teasing out human generated sound

Open floor for Guest input

Mac

Was a performer on stage.

Subwoofers from another stage were interfering with our dialogue on our stage.

Jon Steinhart

2 issues here.

Recorded music vs amplified music

I would like to see more attention to sticking to the guidelines.

Was pretty good this year, with the exception of Sunday night.

Jay

Biggest concern is sleep deprivation

Side concern- how many times I encountered booths playing pre recorded music.

Homework

Lily

Our task is to create a framework for community agreements, and also create a suggestion for a guideline change for the BOD to approve.

Homework- Read our current guidelines and write a 200 word or less community agreement example. What do you think a community agreement could be in relation to the current guidelines, and how we can change the guidelines to serve our community.

The Permitting Process is a piece of the puzzle. After doing permits for a year, suggestions for changes to the permit process.

Application content varies Online vs in person @ QM

Add more specific fields for obtaining contact info to permit application

Goal to meet in person with all applicants, thus establishing a community agreement (in person agreements adds personal accountability

Permits get shared with all Bums for discussion/vote prior to/ and reviewed post event Occasional adjustments made to timing of permits with regard to overlapping events/locations

Would be efficient/helpful to have a map with sound travel data stats while voting on approval Larger window of time required for permit application submission would be helpful

David Adee

Is there any pre recorded sound being permitted?

Joolz- it is not always specified-

David

If a DJ is manipulating pre recorded sound is that a performance?

Joolz

It is not clear

Elijah

Currently guidelines state periods of live mix performance, where sound is overlapping, is acceptable.

Kyle

Surprised at the crunch time (48hrs) with the permitting process. Idea- Early submit digital experience to help offload workload? Logistical challenges or other resistance?

Joolz

Have to cater to digital savvy community as well as non digital community

Lily

On site connectivity issues are a factor Have to have paper backups always

Kyle

Would early submission requirements help with troubleshooting digital challenges?

Meg

As online permit was refined more and more people chose digital format

Lucie

Appreciate the permit process explanation

Should be a longer process

Sound could be juried in in advance

Several people wrote letters to the BOD about sound in the past. Did the sound team ever receive those letters of concern?

Why aren't we following the same procedures for sound that we do with other juried in content?

Lily

Letters written to the BOD are confidential and for the BOD to determine how/who to share with. Mgt team contact info is available for direct communication.

Daytime sound is juried in. Non public hour sound is similar to non juried craft sales after hours.

Lucie

If BOD receives a letter/complaint, MGT team should receive the letter as well

Kirsten

Window of time to apply was extended from 24 to 48 hrs this year and there is no opposition to suggesting a bigger window of time.

BOD determines who and how to share info that comes to them. No Staff or managers receive BOD emails

Elijah

Assuming positive intent is helpful

There are differences

Daytime represents a "Brand"

Night time - volunteers give time to produce this event and enjoy night programming

David

2 am cutoff time for permitted sound.

Did we negotiate that time?

How is that determined

Joolz

County rules

David

If the county said 4 am would we allow 4 am?

Joolz

We abide by county law

David

Are we implying that volunteers off at 12 need amplified sound to enjoy themselves?

How is applicant checking with community prior to submission if the sound travels across distance?

Lily

Can we get into those questions later?

Meg

Process of permit came about because random sound was happening everywhere. Was originally for neighborhood

Not always approved to 2 am.

Now looking inward (internal neighborhood) to further the efforts/

Kirsten

Discussing times varying depending on the day. (Thurs vs Sat)

Paxton

Original sound application came from sound summit 10 years ago.

Kirsten

Let's be careful not to box ourselves in Homework- what is a community agreement? Lets also look at whether that is the answer or not? Are there other ideas/suggestions for achieving this goal?

Homework review/comments

Genevieve

Community agreements are often consensus based, and more about the process.

I think what would be most applicable is an operational agreement.

People can sometimes experience power dynamic struggles that impact a community agreement negatively.

The BOD should create operational policy that gives clear boundaries, rules, and consequences.

Lucie

Perhaps it is all about the location, and not the community agreement?

Elijah

We need zoning input

Neighborhoods are going to self identify. It could be a great tool for contacting and working on neighborhood agreements. Neighborhoods that already have names will have an easier time. Have camp hosts get together and make community agreements in advance of an event. Then get a map and add the neighborhood info to it.

Relational agreements will have logistical challenges.

Dr Dan

Operational agreements- perhaps a healthier approach top the sound issues we are facing, rather than asking for neighborhood agreements and pouring energy into conflict resolution related to sound. On the other hand, the neighborhood agreements that we are talking about could lend themselves to healthy discussion about other topics that need/could benefit from community and neighborhood consensus.

Paxton

Would like zoning discussions for inside the 8 especially.

What if the oneness of neighborhood agreement is on the person holding the sound permit.

There should also be a reporting procedure for neighbors.

Kyle

Building equity through the process is really smart.

Love zoning idea/conversation

A method to be able to clearly submit a complaint, or understand who is responsible for the event in question would be really helpful.

People tend to have a worse reaction when they are surprised. If Folx were notified in advance, they could plan for a 1 am end time.

Joolz

The person filling out the application is the person responsible.

That is why I need more contact info from applicants.

Love the idea of zoning.

Elijah

Building networks of communication will not happen overnight but if we can plant the seed we can help grow a deeper sense of community. Consensus process is totally possible, it just takes time.

Joolz

Education +++

We need to know why and how.

Genevieve

History of planning and process ...

Zoning=land use planning

Non Task Force member input

Jay

Pre recorded music- Prohibited in guidelines.

Could we rephrase guidelines in a positive light? Rather than "this is prohibited" could we say "Music will be live"

Elijah

I am a DJ and also an instrumentalist.

The amount of skill that goes into DJ sets is worth taking a look at. I think that is why it is allowed in the guidelines.

Modality of purposefully

Jon Steinhart

We are all hard working. Comments about how hard working crews need recorded music is not valid.

Sound profile- sound spectrum

Anything below this is inside the neighborhood and above is outside.

Maybe someone needs to put flags in hoods that are in sound zones to inform people of permitted sound happening, and permits need to be provisional.

Really need to come up with a number that says what is a safe sound level.

Are we responsible for hearing damage?

Went from a large number of small performances to a small number of loud ones.

Thank you for all of the greatest comments. I think we should be looking at zoning. It could remove bias. Where are the appropriate zones?

Elijah

Let's think about building communities.

What are those communities?

How can they be best represented?

iii. Section 11. Entertaining at the Fair.

Entertainment is scheduled throughout the Fair. No battery

powered amplifiers, radios, tape recorders, or recorded music are allowed on paths, stages, or in stage areas unless provided or approved by OCF Entertainment Crew coordinators or Fair

Management. Unscheduled performers are expected to comply with the Wandering Performer Guidelines, available at the Check Inn booth at Entertainment Camp or on the oregoncountryfair.org and oregoncountryfair.net websites. Please contact the nearest Information Booth if a performer is blocking a path. Friday through Sunday of the Fair, battery carts devoted to stages will be used only for acts coordinated and scheduled by Entertainment coordinators. Late-night acoustical venues respectful of the camphoods and needs of the Fair Family are encouraged. Tolerance of those who want to dance and celebrate is also appreciated. See Section 51 for additional Sound

Section 51. Sound Amplification.

Community agreements. Because we camp so closely together, amplified sound, whether live or recorded, projected beyond the intended audience creates problems for other Fair Family. Please consider others before you turn it up. Please be respectful of your impact on acoustic musicians, exhausted kids and parents, and Fair Family with early morning shifts. Camp hosts, coordinators, booth representatives, and campers are asked to develop and negotiate neighborhood agreements before the Fair regarding sound levels and noise guidelines and to collectively coexist in a peaceful manner. If conflict develops, the Management Team will intervene as needed. Conflict resolution decisions made at that time by the Management Team must be honored by all involved parties and will be reviewed

post-Fair.

Amplified sound permits. If you are planning an event involving amplified sound on the Fair site outside of the event season, you must obtain a permit from the Site Manager. During OCF Main Camp through post-Fair you can pick up a permit application at Quarter Master. Return the application to QM or Fair Central for review by the Management Team who will consider requests on a case-by-case basis. Sound Amplification Permits may be

determined, in part, using some or all the following criteria: sound sheds, decibel levels, respectful interactions, and other permitted amplified events in proximity or on consecutive nights in the same location.

Timing. All Sound Permit requests and timing issues are subject to Management approval all year long. Amplified sound will comply with Lane County ordinances per our agreement with the County. All amplified sound taking place on OCF stages during the

weekend of the event are subject to Stage Coordinator approval, Community Agreement, and final OCF Management review and approval.

Types of amplified sound. Amplified sound allowed at the OCF is that which is sung, played, or mixed by the musician or DJ and respectfully broadcast to the immediate area and audience with the understanding that sound circles overlap and not always to the benefit of others. Pre-recorded music is not in line with our emphasis on the handcrafted— whether art, food, or music. You are encouraged to turn off pre-recorded music, unless it is part of a live mix performance, dance, or stage act.

There are ongoing efforts among the Board, Management, and other Fair volunteers to understand and design our soundscape to meet the needs of our intergenerational family and our neighbors in Veneta. By working together and understanding that there is a wide range of requests, requirements, and desires, we can come to agreements across campsites and camphoods that meet the needs of most people much of the time. Therefore, this

guideline is an evolving process and will be subject to annual review by the Board of Directors.

Would like to see in the guidelines- no un-permitted amplified sound is allowed. Would aid in getting better data. Ex: some are turning sound up in response to unpermitted loud sounds competing with their permitted sounds.

When Granting permits please consider the spacing of things. Noise pollution in some areas as a result of too many sounds in one area.

Concern with letting some have amplified music and not others. Ex: Site crew and booths playing amplified sound during the public fair hours and early amplified sound while crews are working in the morning

Elisio

Clarifying question- currently music being a great crew motivator and also acting as a way to keep folx aware of our presence, would Site crew need a sound permit from friday to sunday?

Joolz/Kirsten Reply- this taskforce was to address community agreements. There is not currently an exclusion or exception. Not currently in guidelines, not in our current purview- can move into this after this initial mandate is accomplished

Added no pre recorded music allowed- that language does potentially impact working crews

Amy Hand

That is sort of covered in the current guidelines with prior authorization from mgt.

Filling sinkholes during the event is outside of site crews scope, and when needed to be done the music can motivate workers as well as create a safety boundary.

End goal is to preserve the ambiance of the event during public hours and at the same time, with mgt approval, crews should be able to use music for crew motivation and safety buffer

Excited about transition to standards vs agreement, having more accountable conversations with mgt is moving in the right direction. Can't please everyone, but this finds a good balance that equips us to make decisions as humans and have more accountable conversations

Jay

Impressed with all the work ahead as well as work done so far. No doubt that out of this will come more sound permits. Confident that we will find a way to make this work for everyone. Hopeful for acoustic only zones. Appreciate the work that recycling and site does, and also recall a time that those crews did not have recorded music. Remember a time when there were live musicians on the trucks. Need spotter for safety in addition to music.

Julie

Hopeful that the work you are doing will help folx get back to finding more acoustic music. Remembering the old days when acoustic music was every so many feet on the path. Hearing people wanting electronic music. Silent Rave? Can we have more of those? Do they need a permit? How can we encourage more of that?

 Elijah response- Started in the creamery booth- people felt sad about the lack of DJ culture and dance music created silent rave- vinyl DJs and finding ways that DJ culture can be shared at fair. AS generations continue, encouraging buy-in to fair, folx hope for more consideration to youth musical preferences. It is prohibitively expensive. Silent Raves from 2a-6a? Elijah

Possibility to use camp host system to make decisions from the bottom up. Adding "who is your camphost" would enable better data and ways to hold groups accountable to decisions made as a group. Fair will continuously evolve, it is important to involve everyone in decision making. Renegade events happen because they feel like our programming does not currently host enough
