Booth Selection

Sit back and relax! This process can take 3-4 weeks to begin.

Booth selection will happen in the order of your juried ranking. We will reach out to you when we are ready for your selections. Please be patient, as this process takes several weeks *after* we begin. The 1YO team will email with a photo album of available booths and ask for your top 5+ choices. The link will include addresses and approximate camping. Please understand that space at fair is very limited, and camping is not guaranteed. You will only have a week to make your selections, and placement is in order of first responses, so please make your selections quickly. We are happy to help with any questions about the available booths.

People, Passes & Payments

You must share your Booth with another Approved Crafter if you choose a full size booth. They can be selected from the Wait Share List, which will also be attached to the Booth Selection email, or you can choose an approved crafter you have networked with. The Wait Share List will also be published in the Fair Family News in May and June and available on the OCF Website. There are some 1YO Booths that allow a single crafter, and if they are still available, they will be identified in the email.

Each 1YO Crafter is allowed 4 Wristbands and 2 Vehicle Stickers. The Wristbands (Standard Passes) will allow you and your guests access to the site overnight. If you are sharing a full size booth, your Booth share will also receive 4 Wristbands and 2 Vehicle Stickers. You are allowed to purchase Worker Day Passes if you need additional help.

Once your Booth has been assigned, you will receive another email from our team with a link to enter the names and necessary information to register yourself and your guests in the Sunshine database. You will need to assign who will receive your vehicle stickers. Don't worry—if you need to make any changes, email us, and we will take care of you.

Camping is not guaranteed at fair. It is based on which Booth you select, and many booths have limited capacity. Large tents will not fit in most areas. You will need tents with small

footprints. Some booths will not have camping. We have a Camping ReSolutions crew available once you are at fair to help place you. This placement will be anywhere at fair they have found room and will probably not be by your Booth.

If you stay off site, we do have bus options. Starting at 7 a.m., a free bus leaves from Valley River Center, which has free parking.
