ANNOUNCEMENTS

Nick said that the Emerald Ash Borer (EAB) is now in the Willamette Valley. Nick is on the OCF's EAB Task Force. Last Saturday he was out here as part of the work group flagging non-Ash saplings near where people camp. A lot of people turned out to help. They found a lot of non-Ash saplings for our future canopy. If you see purple flagging on a seedling in our forests it is a non-Ash sapling that we hope will grow to become part of our canopy to replace the Ash trees that we are going to lose to the EAB. Please don't camp on it or disturb it. There is a QR code on the flag that you can use to access more information. Later in the meeting Maeve asked if we will be planting more trees and Nick replied that yes, that is part of the process.

We have two robin's nests in Energy Park this Spring. One up on the Center Booth, stay off the tower please. And one in the tree that shades the Sound Board.

Hi Gaelen; I apologize for my nonzoomability and automotive difficulties which have kept me out of meetings- But as far as shade I have a tye-dyed parachute Fairly underutilized if that could be of use anywhere. (you probably remember it) I am going to be at Fair most of the time now, when I'm not tending my cat and garden at home. (If pickup and gas \$ allow.) As a Vegmanec I expect to be removing invasive species: NB: Canary Reed is invasive, and if cut before seed set, it's great under a tent on wet or uneven ground. I will be harvesting some before it sets seed. As a landsteward I have been issued purple tape for marking any Non-Ash tree saplings, as they will grow much faster as the borers arrive. Ash trees die. I hope we can make EP camping a model for the Fair. (as the ash crashes in EP are a taste of what will be the future. Personally I hope to be occupying no more than a 1 sleeping bag size tent. Do you think we should stage a "Green Ass Borer" costume contest? I hope I can share the story of how my traditional tent site was home to a Beaver family when the Long Tom was in flood, and our little swale was bank-full. There are still beaver sticks around back there in camping.

Ryan said that he also has shade cloths that we can use. He has looked at it and we can hook them up to the trees, but he won't have time to do it.

So, it sounds like we have the materials, we just need some climber type people to actually put it up and take it down.
