6. The Fine Print

1. All adult Late Night Trippers are required to present a 2026 "Camping Pass" wristband or a photo ID "Camping Pass" issued by the Oregon Country Fair, along with a Late Night Trips Bus Pass, to board any scheduled Late Night Trips.
2. Every Late Night Trips Bus Pass holder is assured a seat on their selected trips.
3. * No one under 18 years old will be allowed to ride a Late Night Trips bus without being accompanied by one of the adult signatories on his/her/their Registration Form.
4. All Registration Forms and payments (Checks or money orders) for LNT Bus Passes must be postmarked or received **before June 25, 2026** at the OCF address below.
5. No smoking or drinking alcohol on the bus.
6. Alexander Limousine & Oregon Party Bus of Veneta, Oregon (USDOT#2017044) will be responsible for operating the bus and providing scheduled transportation services between the OCF Bus Stop area, Valley River Center, and the Eugene Downtown Public Library on Thursday, Friday, Saturday, and Sunday during the 2026 Oregon Country Fair.
7. Each Late Night Tripper is responsible for arriving at the designated bus stops on time. Buses will depart as scheduled. The Oregon Country Fair and Alexander Limousine & Oregon Party Bus are not liable for missed rides to or from Eugene if you miss your scheduled departure.
8. Neither the Oregon Country Fair nor Alexander Limousine & Oregon Party Bus are responsible for any items left on any Late Night Trips buses.
9. All Late Night Trips Bus Passes will be available for pickup at the Troubleshooting Window at the Wristband Booth.
10. Late Night Trips Bus Passes will be sold on a first come, first served basis and there will be no refunds.
11. Thursday Only riders will not be issued tickets or passes. Their names MUST be on the Thursday manifest.
12. **By signing below, I/We understand and agree to the Fine Print above. I/We have enclosed our payment. I/we are responsible for distributing the passes to everyone listed on this Form. Anyone over 18 listed on this Form must show photo ID when picking up his/her Bus Pass(es).**
